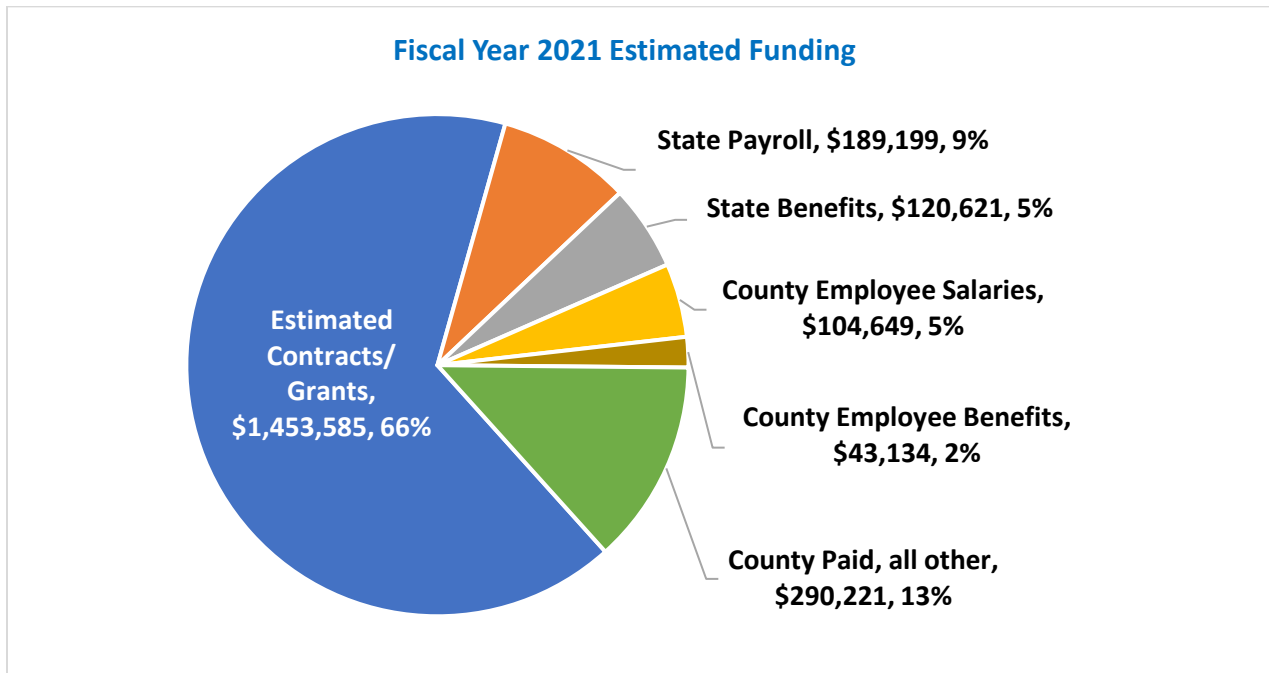


## Sheriff's Department Funding Sources BENNINGTON COUNTY



### The Sheriff's 5 Percent

The Sheriff takes a varying percentage for eligible contracts as is allowed by statute. It is taken on a case-by-case basis depending on the financial health of the department. Any funds not taken remain at the department for use for salaries, equipment or other related costs associated with the administration of the contracts.
